A. The temporary appointment of above candidates shall be subject to fulfillment of the following conditions before the concerned Head of the department/office/Drawing & Disbursing Officer, who will allow the candidate/s to join, subject to production of the following original documents within 21 days from the date of issue of this order:-



- i. Academic/Technical qualification, Certificate of Master's Degree in Economics/Statistics/Mathematics/Commerce/Computer Applications and Information Technology;
- ii. Matriculation/Date of Birth Certificate;
- iii. Health Certificate Issued by Chief Medical Officer;
- iv. Permanent Resident Certificate issued by the competent authority;
- v. Certificate from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee;
- vi. Reserved Category Certificate (in case candidates belong to reserved category);
- vii. Affidavit and Undertaking duly attested by Judicial Magistrate 1<sup>st</sup> class on the devised format enclosed with SRO-412 of 2009 dated 30.12.2009 (Annexure 'A') and (Annexure 'B');
- viii. Migration certificate from the competent authority, where under eligible for seeking employment under Hon'ble Prime Minister's Special Package for Kashmiri Migrants; and
- ix. **The appointee shall be on probation for a period of two years.**


B. Consequent upon the above, appointees are adjusted/posted in the office(s) shown against each as per details :-

C. The appointment of the above candidates as Statistical Assistants shall further be subject to the following conditions :-

- i. The appointees shall give an undertaking duly attested by the 1<sup>st</sup> Class Magistrate in the shape of an affidavit to the effect that in case adverse report about her character and antecedents is received from Inspector General of Police (CID), J&K to whom a reference shall be made by the concerned HOD/Head of the Office/DDO, the candidate shall have no right to claim for her appointment as Statistical Assistant and his/her appointment as such, shall be deemed to have been cancelled ab-initio;
- ii. If on verification, the certificate(s) produced by the appointees are proved to be fake or forged or from un-recognized Institution/ University, the appointment shall be cancelled ab-initio;

- iii. The salary of the appointees shall not be drawn and disbursed to her unless the satisfactory reports in respect of (i) and (ii) above are received in her favour;
  - iv. The clause (iii) & (iv) of the Government Order No: 58-DMRR&R of 2017 dated 29.07.2017 will regulate the disbursement of salaries of the employee;
  - v. The appointees shall be governed under New Pension Scheme as notified vide SRO-400 of 2009 dated 24.12.2009;
  - vi. The post shall be supernumerary and appointments against these posts are made in terms of Jammu & Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules 2009 and borne under Security Related Expenditure;
  - vii. The inter-se-seniority of the appointee shall be strictly as per her merit in the selection list furnished by the SSRB and endorsed by the PD&MD vide No:PD/NG/13/2019 dated 25.04.2019;
  - viii. The Seniority of the appointees shall be fixed at the places on the posts of their first appointment in that particular grade/service (In terms of SRO-412 dated 30.12.2009.
- D. In case, the appointee migrates from the Kashmir Valley at any time during her service tenure, for any reason what so ever, her appointment/service shall stand terminated without any notice, itself by the action of her migration.
- E. The candidate who fail to join within a period of 21 days (twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice as per the circular issued by General Administration Department vide Circular No: 08-JK(GAD) of 2019 dated 04.12.2019.**
- F. This order is issued without prejudice to writ petition(s)/suit, if any, pending /sub-judice before the Hon'ble High Court or any other Court of Law or any order which may not be presently within the knowledge of the Directorate.
