Subject: - Filling of Annual Property Returns by the Public Servant within stipulated date every year - regarding



Sub Section 2 of Section 9 of the J&K Public Men and Public Servants Declaration of Assets and other provision Act, 1983 lays down that it is mandatory on the part of every Public Servant to submit annual returns of the assets held by him and his family members in the month of January every year and shall indicate the reason for increase, if any, in the assets and source thereof.

The General Administration Department vide Circular No. 04-GAD(Vig) of 2015 dated 28.01.2015 has reiterated the above section of the Act and impressed upon all Administrative Secretaries to ensure that all Gazetted/ Non-Gazetted Officers/ officials shall submit the returns of the assets annually. The particulars of the defaulting Gazetted officers shall be submitted to the General Administration Department through Administrative Department and in respect of Non-Gazetted officials, the Administrative Secretaries shall take a review at his/her level and take further action against the defaulting officials as may be required under rules.

As per the Act all the Government Officers/official are required to submit in triplicate the Annual Statement of property by or before 31st of January of the year following to which the statement pertains.

As such, it is, enjoined upon the all Officers/officials of Economics & Statistics (Gazetted/ Non-Gazetted) Cadre who have not submitted their Annual Property Returns for the year 2020 are hereby directed to ensure that the Annual Statement of Property is submitted to the Directorate of Economics and Statistics J&K Jammu/ Administrative Department (Finance) Civil Secretariat, Jammu in triplicate for the year 2020 at the earliest.
